**DECLARATION OF KEVIN LEWIS IN SUPPORT OF
PLAINTIFFS’ MOTION FOR CLASS DISTRIBUTION ORDER**

I, KEVIN LEWIS, declare as follows:

1. I am the owner of Media Stew LLC, a firm that in part engages in database management for litigation. This declaration is submitted in support of Plaintiffs’ Motion for Class Distribution Order.

2. I initially worked on the above-captioned matter to help Plaintiffs’ Counsel in obtaining and processing electronic discovery obtained from Duke, including information relating to potential class members.

3. I worked with Plaintiffs’ Counsel and the claims administrator, The Garden City Group (“GCG”), in processing the database information to provide the best mailing addresses for potential Class Members when the initial notice of class certification was sent.

4. Since the case has settled, I have worked with Plaintiffs’ Counsel and GCG in: 1) sending the notice of settlement; 2) working with the database information to aid GCG in processing the

original claims; 3) working with the database information to process claimants' attempts to cure their deficiencies; and 4) determining the appropriate payments to claimants.

5. The claims GCG received through July 31, 2016 and deficiency responses received by December 12, 2016 have been fully processed and are scheduled to be paid to Authorized Claimants and Late But Otherwise Authorized Claimants from the Residential and Non-Residential Funds.

6. I have been paid a total \$5,805.00 out of the Settlement Fund to date. I have outstanding unpaid invoices of \$88,755.00.

7. Attached hereto as Exhibit A are my unpaid invoices.

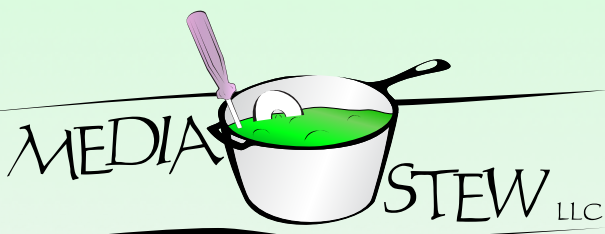
8. I will continue to support the claims administration efforts as needed going forward.

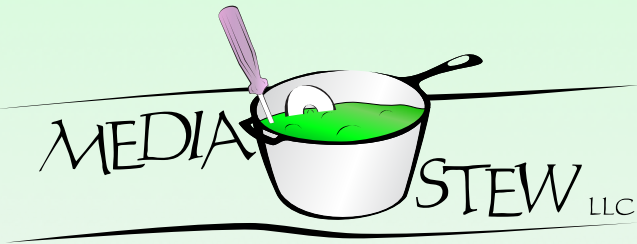
